Dear Glastonbury Landowner,

September 22, 2025

Welcome to the Glastonbury Landowners Association (GLA) Annual Election. Your vote is your voice, and we want to hear from you. This year we have five candidates vying for director's seats. Three candidates from North and two in South Glastonbury. And you will be able to cast a vote on important Bylaw updates and changes. Enclosed are:

- One election and a Bylaw changes ballot for the designated property/parcel number listed on the mailing label.
- Interesting and important statements from the candidates.
- A pre-addressed, ballot return envelope.

Voting by Written Ballot

The 2025 Election is by written ballot *only* as authorized by GLA Bylaws, VI.D. (3). The GLA accounting firm, Accounting & Tax Solutions (ATS), in Livingston, will follow GLA election procedures and confidentially process all ballots. "No ballot cast during a written-ballot only vote can be revoked." Bylaws Article VI D. (4).

Candidates' Terms

This election cycle, there are eight (8) open positions on the Board:

North Glastonbury landowners may elect up to four (4) Directors – three for 2-year terms; one for a 1-year term.

South Glastonbury landowners may elect up to four (4) Directors – three for 2-year terms and one for a 1-year term.

North and South Glastonbury landowners may elect one (1) Ombudsman, each for a 1-year term.

Candidates

- Three (3) candidates, Claudette Dirkers, Doug Gill, and Ryan Kinports are running for North Glastonbury Directors' positions.
- Two (2) candidates, Tim Brockett and Christine Farrar are running for South Glastonbury Directors' positions.
- No candidates are running for Ombudsman in North or South Glastonbury.
- You may write-in a landowner for any position and check the box to vote for them.

Write-in candidates must be members in good standing as defined by Covenant 3.19 and willing to be nominated. Candidates must remain in good standing throughout the election period or they forfeit their candidacy.

Who Can Vote

Landowners must be up to date on all assessment payments by October 31, 2025, in good standing on every lot they own, and cannot be in violation of the GLA Governing Documents.

Mail or Hand-Delivery – 100% Confidential

- You may mail or hand-deliver your ballot to the ATS office, 303 South B Street, Livingston, MT 59047. **BALLOTS MUST BE SUBMITTED IN THE ENVELOPE PROVIDED.** *Do not include anything in the envelope except the ballot.* The ballot envelope has your name and return address on it, so ATS may note that you voted. The envelope will remain sealed until after the election ends. The ballots are placed in a secure box. The envelopes are separated from the ballot before tabulation to maintain voter confidentiality.

E-Mail - Convenient but not confidential

- Scan or photograph your completed ballot and e-mail to ATS at: [atsoffice.ats@gmail](mailto:atsoffice.ats@gmail.com) with the subject line “E-mail Ballot.” In the e-mail body, provide the name and parcel number for which the ballot is designated, and as addressed on this packet, e.g., “Jones / SG 264-A”. Members who own multiple lots: PLEASE FILL OUT AND SUBMIT SEPARATE emails for each parcel.
- Ballots must be emailed to the ATS office ONLY from an e-mail registered with the GLA. Ballots sent from unregistered GLA email addresses will not be valid. To register an email with the GLA, or ask which address we have, please contact us at info@glamontana.org
- ATS must receive your e-mailed ballot by 5:00 PM (MST) on Monday, November 3, 2025.

Complete the Ballot

Members who own multiple lots will receive a ballot packet for each individual lot. PLEASE FILL OUT AND SUBMIT EACH BALLOT SEPARATELY. Ballots must be received by our accounting firm, Accounting Tax Solutions (ATS), no later than 5:00 PM (MST) on Monday, November 3, 2025.

Each ballot contains two main sections, GLA Board Candidates and GLA Ombudsman.

GLA Board Candidates

- North Glastonbury Landowners may check up to four boxes.
- South Glastonbury Landowners may check up to four boxes.

You may choose to check fewer than the allowed number, but not more than the allowable number of boxes or your ballot will be voided. You may write in one or more candidates and vote by checking the box next to their name. Write-in candidates must be Landowners in good standing and willing to serve on the board if elected.

Ombudsmen – North Glastonbury and South Glastonbury may check one box.

One Ombudsman (NG or SG) serves for a term of 1-year. Write-in Ombudsman candidates must be Landowners in good standing and willing to serve if elected.

Annual Meeting, Election Results, Seating of New Board Directors

The GLA Annual Meeting is on November 15, from 11:00 AM to 2:00 PM at Emigrant Community Hall. The President, Treasurer and committee chairs will report on their accomplishments and finances. Election results will be announced during the meeting. Snacks and beverages will be available and everyone is encouraged to mingle before and after the business presentations.

Newly elected Directors and Ombudsmen will be officially seated at the December 2025 Board meeting.

Ryan Kinports – Incumbent For North Glastonbury Director

I am a licensed architect with commercial and single-family residential experience currently working as a contractor building our full-time home in North Glastonbury. Prior to that I worked in AAA video-game development. Currently I serve on the board and on the Project Review and Community Property committees.

Urban planning and landscape design are significant interests of mine. There are a number of long-standing issues the community faces that I would enjoy working towards solving.

We should look to face the battles of today rather than the past. My wife and I want to raise our children here and make it the best possible environment for all residents. Road improvements that have lasting impact, the creation of a community park, and setting up the GLA to be fiscally solvent for the long run are all ideas worth pursuing.

Claudette Dirkers – Incumbent for North Glastonbury Director

I have enjoyed working as GLA Treasurer and with Road, Governing Documents and Election Committees as part of a team led by President Doug Gill on the 2025 GLA Board of Directors.

- As Treasurer, I mailed personalized letters to landowners with past-due accounts one month after missed payments. And I answered emails about payments, assessments, land sales and more.
- The Office of the Treasury implemented a streamlined collections process that reduced yearly past-due assessments by 33%.
- My office worked closely with the Project Review Committee to ensure that all assessments and fees were paid before construction projects could be considered.
- I inspected road conditions for the Road Committee and helped with safety sign selections.
- My service on the Governing Documents Committee included researching and drafting language for upcoming Bylaws changes.
- For the Elections Committee, I assisted with creating nominations and ballot documentation.
- In my spare time, I edited GLA meeting minutes, newsletters and managed mailings of quarterly assessment statements.

My two-year term is almost completed. I ask for your vote so I can support newly elected Directors and help our team build upon their 2025 successes.

Douglas Gill – Incumbent for North Glastonbury Director

Each parcel, lot or tract is allotted one ballot/one vote. Landowners who own multiple parcels receive one ballot for each lot they own and should return each ballot separately.

BOARD CANDIDATES

Check the boxes for up to **four(4)** candidates.

The three candidates who receive the most votes will serve 2-year terms. The candidate with the 4th highest vote total will receive a one-year term.

Write-in candidates must be eligible landowners or legal representatives of record and willing to serve on the Board.

~2025 Bylaw Changes Ballot~

In early 2024, a GLA Director asked her sister, who co-owned a parcel with her, to apply for a vacant seat on the board. Her sister considered and later declined the offer. Later in 2024, the same director asked her sister to run for the board in the GLA Annual Election. She accepted, her name was placed on the ballot, and she won a seat. The first meeting of the new board had both sisters serving as directors.

Many landowners felt that a membership interest, a parcel or tenants-in-common, should only be allowed to have one co-owner run for the board or ombudsman. We already allow husbands and wives to serve on the board if they represent distinctly different membership interests. The issue in 2024, was whether a single, undivided parcel, co-owned by two sisters, would allow multiple owners to serve on the GLA Board.

In 2024, a mother and daughter who co-owned a single parcel ran concurrently for a director's position and for ombudsman. Many landowners thought this was a problem, too. They requested that the Bylaws be changed so only one office or position in the GLA may be held at one time by a Membership Interest.

The GovDocs Committee analyzed the issues and sought a solution by adding language to our Bylaws that prohibited both. The law firm of Crowley Fleck studied our Bylaws and advised language changes. They also updated the Bylaws formatting, and dates. Prior to voting, you may study their work by clicking on the link below. Or you may request a paper copy of the Bylaw changes by mailing a request and a self-addressed stamped envelope to the GLA, PO Box 312, Emigrant, MT 59027. The Crowley Fleck language revisions are in blue.
